



Municipal Corporation Rawalpindi Invitation for Bids (IFB)

1. The *Government of the Punjab* has received a credit (Cr No. 5153-PK) from the International Development Association towards the cost of *Punjab Cities Governance Improvement Project* and intends to apply part of the funds to cover eligible payments under the Contract for the work mentioned below. Bidding is open to all bidders from eligible source countries as defined in the *Guidelines: Procurement under IBRD Loans and IDA Credits*.

2. The *Municipal Corporation Rawalpindi* invites sealed tender from the eligible bidders for the works mentioned below:

3. Bidding documents (and additional copies) may be purchased w.e.f **publication till 28-3-2018** from the office of concerned Municipal Office (Infrastructure) MC, Rawalpindi during the office hours for a non-refundable fee of **Five Thousand (Rs. 5000) pak rupees in the shape of CDR** for each set. Interested bidders may obtain further information from the office of concerned Municipal Office (Infrastructure) MC, Rawalpindi.

4. The last date for submission of sealed bidding document is **29-03-2018** at **12:00 PM** and will be opened on the same date at **12:30 PM** in the presence of the bidders who wish to attend.

5. Bids shall be valid for a period of **Ninety (90) days** after bid opening and must be accompanied by security of 5% of bid amount. The bidder shall submit two copies of bid and clearly mention as "ORIGINAL" and "COPY" as appropriate. In the event of discrepancy between them, the "ORIGINAL" shall prevail.


6. All bidders shall be required to submit with their bids, qualification information specified in the bidding documents. This information shall be used to establish through **post-qualification** whether the bidder is qualified to perform the work.

7. Bidders are required to be submitted on **item rate basis** (not on the basis of Composite Schedule of Rates with percentage premium) and the rates and amounts (in Rupees) must be filled by the bidder in figure as well as in words for each item in the Bill of Quantities (Bid Schedule) and provide a total price. Non-compliance may result in rejection of bid.

8. Bidders should give their best and final price in their bids as no negotiations are expected.

9. As provided in the bidding documents, bidders engaged in corrupt or fraudulent practices (including collusion/pooling) will be declared ineligible, either indefinitely or for a stated period of time, to be awarded a contract financed by the World Bank.
